**NOTICE OF THE PREPARATION OF PROPOSED VARIATION NO. 1
OF THE MEATH COUNTY DEVELOPMENT PLAN 2013-2019**

Notice is hereby given pursuant to Section 13 of the Planning and Development Acts, 2000-2013 that Meath County Council, being the Planning Authority for County Meath, has prepared a proposed Variation to the Meath County Development Plan 2013-2019.

The Proposed Draft Variation seeks to vary a number of the objectives in the Core Strategy of Meath County Development Plan 2013-2019. The Core Strategy requires the realisation of a number of stated objectives within specified periods. These objectives seek to ensure that development frameworks and land use zoning objectives of individual centres adhere to the core strategy and in particular the household allocation contained in Table. 2.4 in the Plan. This proposed variation is to clearly outline the manner in which this process will be undertaken and provide clarity of the intentions of the Planning Authority to give effect to the Meath County Development Plan 2013-2019.
