NOTICE OF PROPOSED MATERIAL ALTERATIONS TO THE DRAFT VARIATION (NO. 2) OF THE MEATH COUNTY DEVELOPMENT PLAN 2013-2019

Notice is hereby given that the Members of Meath County Council, having considered Proposed Variation No. 2 of the Meath County Development Plan 2013-2019 and the Manager's Report thereon in accordance with Section 13 of the Planning & Development Acts 2000-2014, have resolved that the Proposed Variation of the County Development Plan be altered. The proposed modifications constitute a material alteration of the draft Variation of the Meath County Development Plan 2013-2019.

The likely significant effects on the environment of implementing the proposed material alterations have been assessed. The Planning Authority has determined that neither a Strategic Environmental Assessment nor Appropriate Assessment is required to be carried out with respect to the proposed material alterations.

The purpose of this proposed variation is primarily to give effect to the Core Strategy of the Meath County Development Plan 2013-2019 and in particular objectives CS OBJ 2, 3 and 5 therein and also to objective ED OBJ 2 contained in the Economic Strategy.
