**NOTICE OF PROPOSED MATERIAL ALTERATIONS TO
DRAFT VARIATION NO.3 OF THE MEATH COUNTY DEVELOPMENT PLAN 2013-2019**

Notice is hereby given that the Elected Members of Meath County Council, having considered Proposed Variation No. 3 of the Meath County Development Plan 2013-2019 and the Chief Executive's Report in accordance with Section 13 of the Planning & Development Acts 2000-2015, have resolved that the Proposed Variation of the County Development Plan be altered. The proposed modifications constitute a material alteration of the draft Variation of the Meath County Development Plan 2013-2019.

The likely significant effects on the environment of implementing the proposed material alterations have been assessed. The Planning Authority has determined that neither a Strategic Environmental Assessment nor Appropriate Assessment is required to be carried out with respect to the proposed material alterations.

The Variation will incorporate the key tenets of the Economic Development Strategy for County Meath 2014 – 2022, as they relate to land-use planning, into the Meath County Development Plan.

The Variation will be referred to as Variation No. 3 and will amend Volumes 1 and 5 of the Meath County Development Plan 2013 – 2019.
