Notice is hereby given pursuant to Section 13 of the Planning and Development Acts 2000-2018 that Meath County Council proposes to make a variation (Variation No. 5) of the Meath County Development Plan 2013 - 2019. The objective of this Variation is to remove the Phasing objective from residential lands off the Staleen Road in Donore to facilitate the supply of social and affordable housing supply in this area.
